

## CHAPTER 135. TRUCK ROUTES

### 135. TRUCK ROUTES

135.01. Reference to Minnesota Laws. Reference is made to Minnesota highway traffic regulation Chapter 169. All regulations of Chapter 169.80 through 169.88 concerning trucks shall govern except as further restricted by the ordinance.

135.02. Definitions. Subdivision 1. As used in this chapter the terms defined in this section shall have the following meanings:

Subd. 2. "Deviating Truck" means a truck which leaves or departs from a truck route.

Subd. 3. "Truck" means any vehicle designed or operated for the transportation of property and whose total weight loaded or unloaded exceeds 10,000 pounds, or is registered with a gross weight of 12,000 pounds or greater.

Subd. 4. "Truck Route" means any street designated as such in this chapter.

135.03. Truck Travel Restricted. No truck shall be operated on any street other than a truck route, except as permitted in this chapter.

135.04. Maximum Axle Limits. The maximum axle limits are determined by the three roadway authorities that have jurisdiction over roadways within the city limits. These limits are shown on the list of truck routes and on the map. The upper number is the maximum tons per axle during the spring weight restriction. The lower number is the maximum tons per axle during other times of the year. All other axle limitation concerning front steering axles, and consecutive axles are listed in Minnesota Statute §169 still must be followed.

135.05. Shortest Route to Destination. Subject to posted seasonal load restriction and State Law prohibitions of vehicular traffic, the operation of trucks is permitted upon any street where necessary to conduct the business at a destination point, provided streets upon which such traffic is permitted are used until reaching the intersection nearest the destination point.

135.06. Emergency Vehicles. The operation of emergency vehicles is permitted upon any street in any city.

135.07. Street Repair or Construction. The operation of trucks owned or operated by the city, public utilities, any contractor or

material men, while engaged in the repair, maintenance or construction of streets, street improvement or street utilities is permitted within the city.

135.08. Truck Routes. The following streets within the City are designated as Truck Routes.

135.09. Map. The Rochester Public Works Department shall keep and maintain accurate maps setting out the truck routes or streets upon which truck traffic is permitted and such maps shall be available to the public.

135.10. Posting Required. The Rochester Public Works Department shall cause all Truck routes and streets upon which truck traffic is permitted to be so signed-posted and shall cause all other streets upon which truck traffic is prohibited to be so sign-posted. No person shall be charged with violating the provisions of this chapter by reason of operating a truck upon a street where truck travel is prohibited unless appropriate signs are posted on such street.

135.11. Police Authority. Any police officer shall have the authority to require any person driving or in control of any truck not proceeding over a truck route or street upon which truck traffic is permitted, to proceed to any public or private scale available for the purpose of weighing and determining whether this chapter has been complied with.

135.12. Owner's Responsibility. In addition to the driver or operator, the owner of any truck being operated with his permission and consent shall be liable for any violation of this chapter.

135.13. Buses. Bus routes established by the common council may be used by the company providing fixed route bus service. A schedule of service hours is required.

135.14. Seasonal Restrictions. During the spring thaw period, when road restrictions are imposed by the Minnesota Department of Transportation on highways under its jurisdiction, the maximum weight on a single axle of a "deviating truck" shall be 14,000 pounds.

135.15. Garbage & Rubbish Collection. Trucks used for garbage & rubbish collection are considered a "deviating truck" while conducting their collection routes. Collection routes are expected to be designed to minimize travel on non-truck routes and are restricted to use

on the day of the week and in the area zoned for collection. When not on a collection route the trucks must stay on designated truck routes.
