

CHAPTER 96. TAXI FRANCHISES

96. TAXI FRANCHISES

96.01. Franchise Transferred. A non-exclusive franchise is granted to CAM Transportation, Inc., to operate a minimum of 15 taxicabs on the public street of the City of Rochester from January 1, 2011, until midnight on December 31, 2016 subject to the terms and conditions of this code. (3989, 11/1/10)

96.011. Franchise Granted. A non-exclusive franchise is granted to R & S Transport to operate a minimum of 15 taxicabs on the public streets of the City of Rochester until midnight on December 31, 2003, subject to the terms and conditions of this code.

96.012. Franchise Granted. A non-exclusive franchise is granted to CAM Transportation, Inc., to operate a minimum of 15 taxicabs on the public streets of the City of Rochester from January 2, 2005, until midnight on December 31, 2010, subject to the terms and conditions of this code.

96.013. Franchise Granted. A non-exclusive franchise is granted to Med City Taxi, Inc., d/b/a Med City Taxi to operate a minimum of 15 taxicabs on the public streets of the City of Rochester from January 1, 2017, until midnight on December 31, 2021, subject to the terms and conditions of this code. 96.014. Franchise Granted. A non-exclusive franchise is granted to Rochester Taxi, Inc., to operate a minimum of 15 taxicabs on the public streets of the City of Rochester from the time this ordinance takes effect until midnight on December 31, 2017, subject to the terms and conditions of this code. (4082, 8/20/12)

96.015. Franchise Granted. A non-exclusive franchise is granted to Yellow Cab of Rochester, LLC, to operate a minimum of 15 taxicabs on the public streets of the City of Rochester from the time this ordinance takes effect until midnight on December 31, 2018, subject to the terms and conditions of this code. (4113, 6/3/13)

96.016. Franchise Granted. A non-exclusive franchise is granted to RST Transport to operate a minimum of 15 taxicabs on the public streets of the City of Rochester from the time this ordinance takes effect until midnight on December 31, 2020, subject to the terms and conditions of this code. (4219, 10/19/15)

96.02. Non-transferability of Franchises. The franchise granted by this chapter may not be sold, assigned, mortgaged, or otherwise transferred without the express consent of the council.

96.03. Additional Cabs. The franchisee shall add such further and additional taxicabs as it determines to be necessary to provide adequate taxicab service to the public.
